Come out on both dates to enjoy an evening of music and dance at Gifford Park. Seating will be at the east bank of the park, so bring your blankets and enjoy the show!


Central Omaha Pony League Baseball

NEIGHBORHOOD SALUTE

The GPNA recently entered Cox Cable's "Salute to Omaha's Neighborhoods" competition, where we will compete with other neighborhoods for a cash prizes. You may remember that we won the competition two years ago. Jim Windorski served as a judge of the competition last year, so we were ineligible to enter. The entry form covered many of our present areas of concern, and we thought it would be valuable to reproduce our responses in each area.

THE ENTRY FORM ASKED US TO DESCRIBE OUR ORGANIZATION'S EFFORTS IN THE AREA OF:

SOCIAL PROGRAMS Our social programs are designed to include everyone in the neighborhood, members and non-members alike. Popular social events over the last year included the Pumpkin Patch and Easter Egg Hunt for neighborhood children, a neighborhood picnic in the park, a garage sale, and a picnic during this year's Spring Cleanup. Additionally, we sponsored a Pony League Baseball Team, the Show Wagon, and Optimists Bicycle Rodeo, all at Gifford Park. Area businesses, such as Kilgore's Restaurant, often become informal meeting places where neighbors gather to grab a bite to eat and discuss the issues of the day.

NEIGHBORHOOD IMPROVEMENT/BEAUTIFICATION Our neighborhood improvement/beautification plans concentrate on positive resources and encouragement for neighborhood beautification. We sponsored two successful cleanups during the year; our Spring Cleanup filled nine dumpsters with trash, sent at least five truckloads of branches to the mulchers, produced \$115 in revenue for recycled aluminum and scrap metal, cleaned many street sewer drains, and helped countless neighbors get rid of trash, brush, and old appliances. A Holiday Decorating Contest helped beautify the neighborhood at the end of the year, We also made a large number of improvements to Gifford Park, working to get a sign erected, grading and seeding the east bank of the park, pouring two concrete slabs, and adding two barbecue grills and picnic tables.

COMMUNICATIONS The Gifford Park Neighborhood Association's number one priority is communication, and our monthly newsletter remains the primary vehicle. We publish twelve issues a year, of which six are mailed directly to members, and six are distributed to every residential unit in the neighborhood. In order to have full feedback, we have added an editorial section, and devote every square inch of the newsletter to news and information (no advertisements!). A survey was distributed to every residence in the neighborhood, allowing neighbors to sound off about their likes and dislikes. We also have active correspondence with area businesses and institutions, and work to encourage open communication among neighbors as a first step to problem solving. In our monthly general meetings, we have invited guests from City Hall (including Mayor Morgan), the Police Division, MAD DADS, St. Joseph's Hospital, Creighton University, Omaha Public Schools and Boystown National Research Institute, as well as several political candidates, to foster two-way communication and address specific issues.

NEIGHBORHOOD PROBLEM-SOLVING/ADDRESSING NEIGHBORHOOD NEEDS Our neighborhood's problems are many, and we try to address them as humanly, firmly, and creatively as possible. Our Neighborhood Walk Group is a unique response to crime — the walkers are a visible sign of our determination to keep crime out of our neighborhood. Our purchase of a large supply of drug-free zone stickers is an equally visible sign that the illegal sale of drugs will not be tolerated in this neighborhood. February was "parking month:" we emphasized the proper parking of vehicles. Members also participated in Police Ride-Alongs and invited a 911 operator to speak at the January general meeting. On a positive note, we collected money, food, clothes, and toys to create Holiday Sharing Baskets, which were distributed to needy neighborhood families.

COMMUNITY PARTNERSHIPS (relationships with schools,

churches, businesses, government)

We are surrounded by large institutions and corporations, which give us a wide variety of resources upon which to draw, as well as issues to address in terms of expansion and peaceful coexistence. As a result, we try to keep the lines of communication open, and to work with these institutions in the best interest of the neighborhood. We have also worked to foster legitimate business activity in the 33rd and California area, and can proudly report that a new business has opened in our neighborhood. City-wide, we continue to be actively involved in city events and activities, such as the city-wide Spring Cleanup, Brush Up Nebraska (we were the only neighborhood association to sponsor a team), and the Blood-Mobile at St. Joseph's Hospital.



ANNUAL REPORT OF THE CHAIRMAN 1990-1991

The GPNA is a very special Neighborhood Association in the city of Omaha. We are an urban potpourri of people who, unlike our suburban cousins, are here for a potpourri of reasons. have large instutitions surrounding us-their need for expansion puts pressure on the residential characteristics of our neighborhood. With each passing year, the texture of the area is changing. There are yet remaining many families with multiple generations living here. There are people who have left and have returned. Our public school is crowded with a very flexible daily census. Our neighbors have the ability to move their residence quickly, within on outside the area. We also have a college population, who occasionally forget that this is our home also. We are not all home owners. We are not all poor. We are a neighborhood wealthy in tradition as many prominant citizens of our čity have had roots in the Gifford Park area.

The neighborhood is fragile at this point in time. The area embraces a large multi-culturist makeup that it is today as potpourri in that respect. It has also helped new neighborhood associations forming. But success could not be ours if not for the faithful membership which made this commitment most worthwhile for me. To all, I thank you for your support and know that your support will continue for our newly elected officers and our fine at large board members. Yours truly will not disappear, I owe the GPNA my continued service as a member of the Board as the Past Chairman.
